WILBERT Burial Urn Vaults are manufactured by the licensees of Wilbert Funeral Services, Inc. ("Wilbert") pursuant to manufacturing and product specifications established by Wilbert. **THE MANUFACTURER OF THIS BURIAL URN VAULT ("MANUFACTURER") DOES HEREBY WARRANT TO THE PURCHASER THAT, UPON NOTICE TO MANUFACTURER, MANUFACTURER WILL REPLACE THIS BURIAL URN VAULT WITHIN 10 DAYS WITH A NEW BURIAL URN VAULT OF SIMILAR VALUE IF, AT ANY TIME**

**WITHIN 75 YEARS (BRONZE TRIUNE BURIAL URN VAULT) AFTER INTERMENT, OR
WITHIN 75 YEARS (COPPER TRIUNE BURIAL URN VAULT) AFTER INTERMENT, OR
WITHIN 75 YEARS (SST TRIUNE, CAMEO ROSE, OR VETERAN BURIAL URN VAULT) AFTER INTERMENT, OR
WITHIN 65 YEARS (VENETIAN BURIAL URN VAULT) AFTER INTERMENT, OR
WITHIN 50 YEARS (MONTICELLO BURIAL URN VAULT) AFTER INTERMENT,**
IT HAS FAILED IN ANY WAY TO RESIST THE ENTRANCE OF WATER OR ANY ELEMENT FOUND IN THE SOIL IN WHICH IT IS INTERRED. HOWEVER, MANUFACTURER CAN MAKE NO CLAIM THAT THE BURIAL URN VAULT WILL ORDINARILY REMAIN PROTECTIVE FOR THE ENTIRE WARRANTY PERIOD.

This replacement warranty shall be void (1) if the burial urn vault is not sealed by Manufacturer (or a representative of Manufacturer); (2) if the burial urn vault is disinterred after burial without notice as provided in this warranty; (3) if the burial urn vault is damaged in or near the cemetery by the misuse of machinery to dig neighboring graves, by negligence on the part of the cemetery, or by acts of God; (4) if the burial urn vault is not buried under at least 18 inches of soil at interment; or (5) the burial urn vault has been moved after burial.

To enforce this warranty, written notice of any disinterment must be given to Manufacturer, with a copy to Wilbert Guarantee Trust Fund (c/o Wilbert Funeral Services, Inc., P.O. Box 147, Forest Park, Illinois 60130), at least 48 hours in advance, and representatives of Manufacturer and Wilbert shall have the right to be present at the disinterment at their option. All claims must be in writing and mailed to Manufacturer at the address shown below within 30 days of the date of disinterment with a copy to Wilbert Guarantee Trust Fund. This warranty certificate must accompany the claim and the purchaser must permit the burial urn vault to be repossessed by Manufacturer at Manufacturer's expense.

NEITHER WILBERT NOR MANUFACTURER SHALL BE RESPONSIBLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF ANY BREACH OF THIS EXPRESS WARRANTY OR ANY WARRANTIES IMPLIED BY LAW. THE PURCHASER'S REMEDY SHALL BE STRICTLY LIMITED TO THE REPLACEMENT OF THE BURIAL URN VAULT AS STATED IN THE PRECEDING PARAGRAPH. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

In the event Manufacturer is no longer in business, the obligation of Manufacturer hereunder will be assumed by Wilbert Guarantee Trust Fund (c/o Wilbert Funeral Services, Inc., P.O. Box 147, Forest Park, Illinois 60130), provided, however, that all the terms and conditions herein shall be complied with. It is represented that the assets of said trust fund at this date are not less than \$25,000.
